# Whiskey Hill Raceway COVID-19 Restrictions & Mandates

- Remove water cooler, notify staff and participants to bring their own, or have water available in opened cases, but not chilled
- Use disinfecting wipes or disinfectant spray and disposable towels to wipe down equipment, supplies, shared work areas and surfaces between uses, shift changes and frequently throughout the day
- Clean frequently touched surfaces such as tables, counters, doorknobs, light switches, pens, keyboards, and cones (when used)
- Maintain hand washing stations or hand sanitizers in and around the paddock
- Remove community food tables
- Staff will be issued a single radio with no hand off between staff members; before storing or when returning, wipe off the radio with a disinfectant wipe
- Close events to any and all spectators
- Require drivers to park at least 6' away from other vehicles
- Ensure hand washing and sanitizer stations around the facility are functional/replenished
- Allow only essential staff in work areas; when not working, staff members should remain in their personal vehicle or follow social distancing protocols
- Place CDC-approved flyers in the paddock to remind people of social distancing and protective health protocols:

### **Pre-Event Communication & Announcements**

- Provide consistent and informative messaging to participants and workers so everyone comes to the event with an understanding of the specific and various COVID-19 safety protocols
- Ask that anyone who is at higher risk for severe illness, feeling unwell, or who has been in contact with anyone that is sick in the last two weeks to stay home/not attend the event
- Remind people of the no-quibble cancellation policy, so no one is pressured to attend if unwell
- Inform participants of protocols they are expected to follow Social distancing, frequent hand washing, face covering, what to bring, etc.
- Notify participants of the COVID-19 protocols being followed by track staff.
- Ensure all track staff workers are aware of the safety protocols that will be enforced on-site
- Encourage participants to come prepared to protect themselves and their vehicles/equipment

### **Gate Entry Restrictions & Mandates**

- Gate attendant shall wear a mask and gloves and sanitize the pen and clipboard after every vehicle.
- Provide separate track waiver sheet for each vehicle.

• Recommend that event organizers notify attendees to bring their own pen for signing in.

# **Outdoor Paddock Area Use Restrictions & Mandates**

- Each specialty location must be equipped with disinfectant or hand sanitizers.
- Limit to 10 workers per specialty area
- General social distancing protocols must be followed
- Require workers to wear masks when a 6-foot distance cannot be followed
- Use plastic garbage bags to transport disinfected equipment, supplies to corner stations and other specialty locations; disinfect after use
- Disinfect all shared work areas and equipment between staffing changes and end of day.
- Only essential, on-duty workers are allowed in specialty work areas
- If canopies/tents are used, leave sides open or removed

## **Registration/Worker/Event Meeting Restrictions & Mandates**

- All meetings must be outside and social distancing protocols followed. Holding meetings via the PA system, FM radio, or via Internet live stream and/or via email is preferred.
- Staff meetings must be outside and social distancing protocols followed; staff meetings may also be held over the radio net.
- Include pertinent information on COVID-19 procedures to normal meeting content.

### Medical/Ambulance Service Provider Restrictions & Mandates

• Medical and Fire Personnel should follow protocols outlined by their employer and local/state recommendations

### **Corner Stations/Flagger Restrictions & Mandates**

- Disinfect shared equipment and supplies before and after each use; use plastic garbage bags to transport equipment.
- Keep the same staff person assigned to the same station during the entire event
- Do not fill the transport shuttle bus to capacity, and have passengers wear masks

### Wrecker/Rescue Restrictions & Mandates

- Each person in the wrecker/rescue vehicle must wear a mask
- Disinfect interior of wrecker/rescue vehicle before and after use
